NGO Agreement form

This is an agreement between _____
 (“**Project Participant NGO**”), and **MAM Movies** (hereby referred as “**I am the Change Film Project Team**”) with respect to NGOs Participant in “**I am the Change Film Project**” and creation of a short film or video (**the “Film”**) pursuant to the terms below. **Project Participant NGO** hereby agrees on behalf of him/herself and the Organization to take part in “**I am the Change Film Project**” (“**Project**”), being produced by the **MAM Movies**.

1. **Project Participant NGO** hereby acknowledges that a “**Making of the Film Project**” (**the “Documentary”**) may be shot during the Film Project, and hereby agrees to allow camera crews to tape Organization during any production stage of the project; and further agrees to immediately provide to the “**I am the Change Film Project Team**” a signed release. This in no way, however, obligates “**I am the Change Film Project Team**” to produce or exhibit the **Documentary**.

2. “**I am the Change Film Project Team**” does not expect any direct monetary remuneration from the **Participant Organization** for making the video under the film project.

3. **Project Participant NGO** and “**I am the Change Film Project Team**” will jointly own, as co-authors, the copyright in and to the **Film**, and hereby agree to the following division of rights:

a. **Project Participant NGO** shall have the non-exclusive rights to use the film for their personal use or any other form of publicity or form they like.

b. “**I am the Change Film Project Team**” shall have the following rights for the video produced during this **Film Project**: to screen, show, exhibit, telecast, broadcast, advertise, market, exploit, and disseminate the Film and/or any portion thereof throughout the universe in perpetuity, via any medium and in any manner whether now known or hereafter invented, including but not limited to theatrical, television (including without limitation all forms of broadcast, cable, and digital television), DVD/home video/videogram (including any videogram successor), Internet distribution and any means of digital download. In no manner limiting the foregoing, “**I am the Change Film Project Team**” shall have the right to use the Film and any portion thereof to advertise, promote and publicize “**I am the Change Film Project**” in any manner and via any medium at “**I am the Change Film Project Team’s**” sole discretion.

c. “**I am the Change Film Project Team**” will have rights to license, sell, or otherwise assign (“license”) any rights in the Film to a third party licensee.

4. **Project Participant NGO** hereby acknowledges that participation in the “**I am the Change Film Project**” is without remuneration or monetary compensation whatsoever. The consideration for participating in the project is the opportunity for publicity or exposure for being a participant, to create a Video which can be used by the **Participant NGO** for their publicity and to engage youth to reach out to local Charities.

5. **“I am the Change Film Project Team”** will not be liable for any special, indirect or consequential damages, without limitation, damages arising under any cause of action, including contract, warranty, strict liability or tort, whether or not **“I am the Change Film Project Team”** has been advised of the possibility of such damages. These limitations shall apply notwithstanding the failure of the essential purpose of any limited remedy.
